

# HLTAID001 Provide cardiopulmonary resuscitation - Refresher

## Course Information Sheet

### About the course

This course is delivered and assessed by **Premium Health Pty Ltd (RTO no 104032)**.



This short course is specifically designed to provide students with the knowledge to perform cardiopulmonary resuscitation (CPR) in line with the Australian Resuscitation Council Guidelines.

Areas covered include introduction to first aid principles, airway and breathing management and cardiopulmonary resuscitation/rescue breathing and early defibrillation.

### Learning outcomes

This course will enable students to:

- Respond to signs of an unconscious casualty
- Perform CPR
- Communicate details of the incident.

### Who should study this course?

This course is particularly geared to provide an update refresher in CPR for students with current first aid certification. The Australian Resuscitation Council recommends an update every 12 months.

Upon successful completion of this course students may be interested in furthering their First Aid training by completing First Aid Level 3.
