

HLTAID003 Provide first aid - Refresher

Course Information Sheet

About the course



This course is delivered and assessed by **Premium Health Pty Ltd (RTO no 104032)**.

This unit develops the skills and knowledge required to provide a first aid response including CPR to a casualty.

Topics covered include:

- responsibility of the first aider
- infection control
- bleeding and shock
- angina and heart attack
- fractures
- soft tissue injuries and head injuries
- asthma, poisoning, and burns
- eye injuries
- safety and injury prevention

Learning outcomes

Students will have gained the skills and knowledge to:

- Provide first aid, including CPR until the arrival of medical assistance
- Understand the role of a workplace first aider including communication and documentation of the incident.

Who should study this course?

This course is suitable for:

- Those who have been trained in first aid previously feel confident in their first aid abilities and wish to update their knowledge and skills.

- All workers who may be required to provide a first aid response in a range of situations and workplace settings and is the minimum training requirement for personnel to be qualified in first aid.

Upon successful completion of this course students may be interested in furthering their first aid training by completing Advanced first aid (Level 3).

Assessment

Students will be required to complete a range of training and assessment tasks including short answer questions, problem solving and reporting activities.

The assessments undertaken during this one day course are the same as for the 2 day course, but the classroom learning assumes prior knowledge and experience and is faster paced.

Students will be required to demonstrate competent CPR on an adult and infant manikin, participate in three first aid scenarios, apply first aid procedures for a variety of first aid conditions and complete a written knowledge assessment.

Unique Student Identifier

From 1 January 2015, all students who undertake Nationally Recognised Training must have a Unique Student Identifier (USI). Your USI means all your training records and results will be in one place.
