About the course

This course is delivered and assessed by The Master Builders Association of Victoria also known as Master Builders Victoria (MBV) - RTO no 3935.

The Medium Rise Structural Principles short course outlines how to:

- Apply the National Construction Code (NCC) and other codes and standards to Class 2 to 9, Type B commercial buildings.
- Apply structural principles to the construction of footings and structural elements in residential and commercial buildings up to three storeys.

Learning outcomes

You will have gained the skills and knowledge to:

- Access, interpret and apply relevant building codes and standards to the construction processes for Type B construction.
- Apply structural principles to the construction of buildings up to three storeys.

Who should study this course?

This course is suitable for:

- Builders, project managers, site managers, forepersons, construction managers, and;
- Other building practitioners involved with the management of small to medium sized building businesses as well as the planning of onsite construction work.

Master Builders Victoria entry requirements

It is a Master Builders Victoria requirement for those wishing to undertake this course that they:

Have basic computer skills as this course is delivered partially online

Due to the accelerated nature of this course, MBV recommend you have at least five (5) years of experience in the building and construction industry. Pre-requisite units for CPCCBC5018

One of the units in this cluster, *CPCCBC5018 Apply structural principles to the construction of buildings up to three storeys*, requires completion of the following pre-requisite units:

- CPCCBC5001 Apply building codes and standards to the construction process for Type B construction
- CPCCBC4053 Apply building codes and standards to the construction process for Class 2 to 9 Type C buildings

Note:

- If you have completed the superseded unit *CPCCBC4001A Apply building codes and standards to the construction process for low rise building projects* within the last three years you may satisfy the prerequisite requirement and may require completing some gap training contact our team to discuss.
- CPCCBC5001 Apply building codes and standards to the construction process for Type B construction is trained and assessed as part of Medium Rise Structural Principles cluster and is therefore not required for enrolment into this cluster.

What you need to bring to class

You must bring a pen and notebook to class.

In addition, you must bring <u>evidence of entitlement to study in Australia</u> to your first class (not necessary if you have already presented this to Master Builders Victoria).

Course structure and duration

Delivery Mode: Blended

The course is delivered over a period of **6 days** or equivalent night sessions.

Upon successful completion of this course, you will be awarded a Statement of Attainment by **The Master Builders Association of Victoria (RTO no 3935)** for the following units of competency:

- CPCCBC5001 Apply building codes and standards to the construction process for Type B construction
- CPCCBC5018 Apply structural principles to the construction of buildings up to three storeys

Note: If you've studied CPC50220 Diploma of Building and Construction (Building) with Master Builders Victoria you may already hold these units of competency or equivalent units of competency.

Assessment

Assessment activities may be a combination of scenarios/case studies, written responses, portfolio of evidence, observations, simulated role-plays, oral presentations and projects. All assessments will be contextualized to a construction workplace.

Assessments are submitted in electronic format through our Learning Management System. Training in the use of this system will be provided on the first day of the course.

Unique Student Identifier
